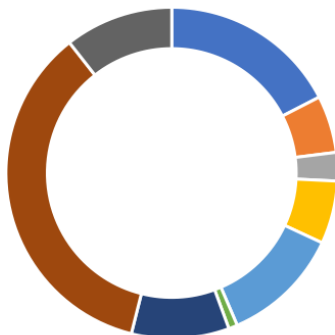

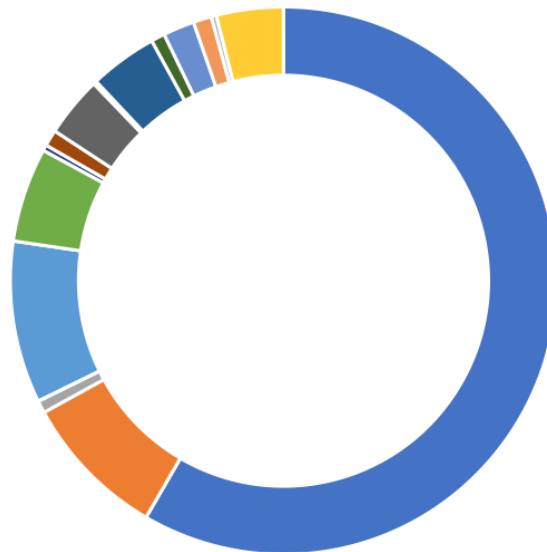

ACCREDITATION

The Cambridge-Guernsey County Health Department submitted their final documentation to the Public Health Accreditation Board on November 27, 2019. Since this process began in 2017, the Accreditation Team has met once a week to review and submit over 330 documents. Next steps include: a documentation review, a site visit, and our accreditation results!

PERFORMANCE MANAGEMENT

The Cambridge-Guernsey County Health Department continues to monitor performance management and quality improvement goals quarterly. In 2019, each department set and monitored their goals. All goals and objectives were met except for the Nursing Department's Goal #5: Establish an EMR/Billing system to provide and maximize vaccine availability and reimbursement. This goal will be renewed in the 2020 performance management plan for further research and evaluation.

CHA/CHIP

The Cambridge-Guernsey County Health Department has contracted with Orië Kristel at Illuminology. The health department held a Community Health Assessment Community Health Issues Discussion forum on November 18, 2019 at the Crossroads Library for local community partners and members to attend. The next steps for the CHA include: 1. Collecting secondary data to review, 2. Conducting survey of adults in Guernsey County, 3. Prioritize health issues, and 4. Begin planning for the CHIP.

VITAL STATISTICS

The Cambridge-Guernsey County Health Department continues to provide Guernsey County residents with easy access to obtaining a copy of a birth or a death certificate. To obtain a birth certificate one must have been born in the state of Ohio. Death certificates can only be issued if the individual passed in Guernsey County.

**BREAST AND
CERVICAL CANCER
PROJECT**

This project is a state-wide breast and cervical cancer screening and diagnostic program offered at no cost to women in Ohio. Services provided include: pelvic exams, pap tests, clinical breast exams, mammograms case management and diagnostic testing, including biopsy and ultrasound if needed.

**CHILDREN WITH
MEDICAL
HANDICAPS**

The Children with Medical Handicaps (CMH) program is a health care program of the Ohio Department of Health. CMH links families of children with special health care needs to a network of quality providers and helps families obtain payment for the services their children need. The health department deploys two registered Public Health nurses to make home visits to families of children with special health care needs and assist physicians and other medical care providers. CMH will pay for diagnostic services for children, regardless of family income.

**REPRODUCTIVE
HEALTH AND
WELLNESS PROGRAM**

The Reproductive Health and Wellness program provides women's health exams including: pap tests, sexually transmitted infection (STI) testing and treatment, clinical breast and pelvic exams, routine lab testing, family planning supplies, education, counseling, and referral services. Male services include: STI testing and treatment, treatment for HPV, education, referral services, and issuing supplies such as condoms.

**WOMEN, INFANTS,
AND CHILDREN
(WIC)**

The WIC program is a federally funded supplemental food and nutrition program. Women, infants, and children who meet income guidelines can receive nutritious foods such as whole grains, fruit and vegetable vouchers, infant formula, baby food, etc. Exclusively breastfeeding mothers are given a more extensive food package. Eligibility requirements include Ohio residents that are breastfeeding, post-partum, or pregnant women, infants and children up to 5 years of age who meet financial criteria and have a nutritional risk.

**TOBACCO
PREVENTION**

The Health Department participates in the prevention of tobacco related disease in use by offering tobacco education in Family Planning, WIC, and General Medical Clinic. The health department also visits local schools and educates students on the risks of using tobacco. Tobacco risk information and cessation techniques are given and referrals to SEORMC are made when the need arises. Staff discusses tobacco cessation with patients in Family Planning, WIC, and the General Medical Clinics and refer to the Ohio Tobacco Quit Line or SEORMC as appropriate.

PROJECT DAWN

Project DAWN is a community-based drug overdose education and Naloxone distribution program of the Ohio Department of Health. The health department has 3 nurses trained to provide this community education program and distribute Naloxone, under the direction of Dr. Colby, to individuals who might be in a position to witness and respond to an opiate overdose. These individuals are trained in recognizing the signs and symptoms of an overdose, distinguishing the type of overdose, performing rescue breathing, calling EMS, and administering intranasal Naloxone.

IMMUNIZATIONS

The health department's immuniation program provides services to prevent and protect the public againts vaccine preventable disease. In 2019, there were five outreach clinics to three locations in the Amish Community during 2019. Walk-in immunizations hours are 2:00 PM to 5:00 PM on Mondays and 8:00 AM to 4 PM on Fridays. The staff also provides immunizatoins to adults and children throughout the week in WIC and during the Women's Health Clinic. All currently recommended childhood immunizations are provided at the optional cost of \$10.00 per immunization.

**GENERAL MEDICAL
CLINIC**

The Health Department offers a General Medical Clinic for residents of Guernsey County who do not have a primary care physician and who are unable to pay the full cost to see a primary care physician. The clinic is held every Wednesday afternoon. Health Commissioner/Medical Director, Dr. Edward Colby serves patients by appointment. Sick patients are scheduled as well as those seeking physicals for work, school, etc. The clinic was held 49 times in 2019.

CRIBS FOR KIDS

The Health Department offers a cribs for kids program to help prevent the number of sleep related infant deaths in Guernsey County. The Health Department's health educator and maternal health case manager provide education to parents and caregivers on the importance of practicing safe sleep for their babies and by providing portable cribs to families who, otherwise, cannot afford a safe place for their babies to sleep.

**MATERNAL HEALTH
CASE MANAGEMENT**

In November of 2017, a maternal health case manager was hired through the funding from Mental Health and Recovery Services Board and the 21st Century CURES grant. The maternal health case manager receives referrals from community stakeholders and provides case management services regarding prenatal care, drug abuse treatment, housing, transportation, nutrition, and parenting education.

FOOD SERVICE OPERATIONS/FOOD ESTABLISHMENTS

The Cambridge-Guernsey County Health Department is responsible for inspecting and licensing all food service operations and retail food establishments in Guernsey County.

In 2019, **195** Food Service operations licensed and **411** inspections were conducted. These include: (**150** food service operations, **16** FSO mobile licenses and **28** vending licenses), **94** Retail Food Establishments were licensed and **178** inspections were conducted. **88** temporary food service permits were issued with **88** inspections completed.

PLUMBING

The Cambridge-Guernsey County Health Department collected **69** residential plumbing permits in 2019. In 2019, there were also **52** commercial permits used, **44** master plumbers, **34** journeymen, **14** apprentices, and **15** associate plumbers.

RABIES PREVENTION/ANIMAL BITES

In 2019, the **102** animal bites investigated consisted of **77** dogs, **20** cats, **1** rabbit, **1** rat, **1** chipmunk, **1** bat, and **1** bobcat. There was **1** non-bite rabies exposure investigated. **110** persons were exposed. The health department sent **14** specimens to the Ohio Department of Health Lab for testing. The **26** specimens being investigated consisted of: **3** dogs, **5** cats, **1** raccoon, **4** bats, and **1** bobcat. They all tested negative. **Six** people started vaccine treatment.

SEWAGE DISPOSAL SYSTEMS

In 2019, the health department issued **91** permits, approved 86 systems, conducted **91** site reviews, registered **30** sewage system installers, registered **11** service providers, and registered **14** septage haulers. The systems that were approved were as the following: **5** leach fields, **28** NPDES, **1** tank to mound, **1** pre-treatment to leach field, and **1** tank replacement.
