ADMINSTRATIVE SERVICES

ACCREDITATION

The Cambridge-Guernsey County Health Department submitted their final documentation to the Public Health Accreditation Board (PHAB) on November 27, 2019. On January 20, 2020 the health department was asked to provide additional documentation for a Completeness Review. The Completeness Review was submitted on February 18, 2020. In November of 2020, PHAB submitted Pre-Site Visit requests to the health department. Those requests were completed and submitted on December 22, 2020. The Cambridge-Guernsey County Health Department is currently waiting to receive their virtual site visit date for 2021.

PERFORMANCE MANAGEMENT

The Cambridge-Guernsey County Health Department continues to monitor performance management and quality improvement goals regularly. In January of 2020, administrative staff met to discuss new and returning goals for the upcoming year. Meetings came to a halt due to the current COVID-19 pandemic, starting in March of 2020. Each department is responsible for monitoring their goals and objectives independently until further notice.

CHA/CHIP

The Cambridge-Guernsey County Health Department contracted with Orie Kristel at Illuminology in 2019. The initial CHA survey was completed in January of 2020 and distributed in the spring of 2020. In July, the draft of the CHA was completed and shared with the Guernsey County Board of Health. The draft was reviewed in August and finalized in the fall of 2020. Goals and objectives were developed for the CHIP when the CHA was completed. CHIP workgroups began meeting in November of 2020 and will continue to meet and discuss goals, objectives and action plans in 2021.

VITAL STATISTICS

The Cambridge-Guernsey County Health Department continues to provide Guernsey County residents with easy access to obtaining a copy of a birth or a death certificate. To obtain a birth certificate one must have been born in the state of Ohio. Death certificates can only be issued if the individual passed in Guernsey County.

NURSING AND CLINIC SERVICES **BREAST AND CERVICAL CANCER PROJECT**

This project is a state-wide breast and cervical cancer screening and diagnostic program offered at no cost to women in Ohio. Services provided include: pelvic exams, pap tests, clinical breast exams, mammograms case management and diagnostic testing, including biopsy and ultrasound if needed.

A total of two mammography clinic was held during 2020 and 25 women were served.

WOMEN, INFANTS, AND CHILDREN (WIC)

The WIC program is a federally funded supplemental food and nutrition program. Women, infants, and children who meet income guidelines can receive nutritious foods such as whole grains, fruit and vegetable vouchers, infant formula, baby food, etc. Exclusively breastfeeding mothers are given a more extensive food package. Eligibility requirements include Ohio residents that are breastfeeding, post-partum, or pregnant women, infants and children up to 5 years of age who meet financial criteria and have a nutritional risk. 1.034 2018 Active Participants 1,061 2019 Active Participants 920 2020 Active Participants

CHILDREN WITH MEDICAL HANDICAPS

The Children with Medical Handicaps (CMH) program is a health care program of the Ohio Department of Health. CMH links families of children with special health care needs to a network of quality providers and helps families obtain payment for the services that their children need. The health department deploys two registered nurses to make home visits to families of children with special health care needs and assist physicians and other medical care providers. CMH will pay for diagnostic services for children, regardless of family income.

TOBACCO PREVENTION

The Health Department participates in the prevention of tobacco related disease in use by offering tobacco education in Family Planning, WIC, and General Medical Clinic. The health department also visits local schools and educates students on the risks of using tobacco. Tobacco risk information and cessation techniques are given and referrals to SEORMC are made when the need arises. Staff discusses tobacco cessation with patients in Family Planning, WIC, and the General Medical Clinics and refer to the Ohio Tobacco Quit Line or SEORMC as appropriate.

PAGE 09 REPRODUCTIVE **HEALTH AND** WELLNESS PROGRAM

The Reproductive Health and Wellness program provides women's health exams including: pap tests, sexually transmitted infection (STI) testing and treatment, clinical breast and pelvic exams, routine lab testing, family planning supplies, education, counseling, and referral services. Male services include: STI testing and treatment, treatment for HPV, education, referral services, and issuing supplies such as condoms.

PROJECT DAWN

Project DAWN is a communitybased drug overdose education and Naloxone distribution program of the Ohio Department of Health. The health department has 3 nurses trained to provide this community education program and distribute Naloxone, under the direction of Dr. Colby, to individuals who might be in a position to witness and respond to an opiate overdose. These individuals are trained in recognizing the signs and symptoms of an overdose, distinguishing the type of overdose, performing rescue breathing, calling EMS, and administering intranasal Naloxone. NURSING AND CLINIC SERVICES

IMMUNIZATIONS

The health department's immuniation program provides services to prevent and protect the public againts vaccine preventable disease. In 2020, there were two outreach clinics to two locations in the Amish Community during 2020. Walk-in immunizations hours are 2:00 PM to 5:00 PM on Mondays and 8:00 AM to 4 PM on Fridays. The staff also provides immunizatoins to adults and children throughout the week in WIC and during the Women's Health Clinic. All currently recommended childhood immunizations are provided at the optional cost of \$10.00 per immunization.

GENERAL MEDICAL CLINIC

The Health Department offers a General Medical Clinic for residents of Guernsey County who do not have a primary care physician and who are unable to pay the full cost to see a primary care physician. The clinic is held every Wednesday afternoon. Health Commissioner/Medical Director, Dr. Edward Colby serves patients by appointment. Sick patients are scheduled as well as those seeking physicals for work, school, etc.

CRIBS FOR KIDS

The Health Department offers a cribs for kids program to help prevent the number of sleep related infant deaths in Guernsey County. The Health Department's health educator and maternal health case manager provide education to parents and caregivers on the importance of practicing safe sleep for their babies and by providing portable cribs to families who, otherwise, cannot afford a safe place for their babies to sleep.

MATERNAL HEALTH CASE MANAGEMENT

In November of 2017, a maternal health case manager was hired through the funding from Mental Health and Recovery Services Board and the 21st Century CURES grant. The maternal health case manager receives referrals from community stakeholders and provides case management services regarding prenatal care, drug abuse treatment, housing, transportation, nutrition, and parenting education.

FOOD SERVICE OPERATIONS/FOOD ESTABLISHMENTS

The Cambridge-Guernsey County Health Department is responsible for inspecting and licensing all food service operations and retail food establishments in Guernsey County.

In 2020, 295 licenses were issued pertaining to food operations (food service and retail).
516 inspections were conducted in 2020 for food operations. During this year, 191 Food Service operations were licensed and 359 inspections were conducted. Those licensed include: 145 food service operations, 20 FSO mobile licenses, and 26 vending licenses. 97 Retail Food Establishments were licensed and 157 inspections were conducted. 7 temporary food service permits were issued with 7 inspections completed.

SOLID WASTE HAULERS

As of 2020, there are 6 licensed solid waste haulers in Guernsey County. 41 trucks are under these licenses. Inspections are conducted once a year.

PLUMBING

The Cambridge-Guernsey County Health Department collected **63** residential plumbing permits in 2020. In 2020, there were also **41** commercial permits used, **43** master plumbers, **34** journeymen, **18** apprentices, and **13** associate plumbers.

RABIES PREVENTION/ANIMAL BITES

In 2020, the 101 animal bites investigated consisted of 64 dogs, 30 cats, 1 skunk, 1 chipmunk, 1 bat, and 3 raccoon. There was 1 non-bite rabies exposure investigated. 101 persons were exposed. The health department sent 16 specimens to the Ohio Department of Health Lab for testing. The 16 specimens being investigated consisted of: 5 dogs, 5 cats, 1 raccoon, and 4 bats. They all tested negative. 3 people started vaccine treatment.

SEWAGE DISPOSAL SYSTEMS

In 2020, the health department issued **90** permits, approved **83** systems, conducted **95** site reviews, registered **29** sewage system installers, registered **13** service providers, and registered **15** septage haulers. The systems that were approved were as the following: **59** leach fields, **16** NPDES, **7** tank to mound, and **8** tank replacements. Of the **90** Permits issued, **48** were new systems, **38** replacements, and **4** tank replacements. **1736** aerators were inspected with reports submitted. The Cambridge-Guernsey County Health Department conducted **522** of the **1736** inspected.
